# A REVIEW OF SEA TURTLE MITIGATION MEASURES ACROSS THE FIVE TUNA RFMO AND OTHER FISHERIES MANAGEMENT ORGANIZATIONS

#### **SUMMARY**

This document compiles the currently active mitigation measures across the five Tuna Regional Fishery Management Organizations (tRFMO) that manage fisheries targeting tuna and tunalike species worldwide, as well as across other Regional Fishery Bodies (RFB) in the Atlantic Ocean and adjacent seas whose areas of competence also include the high seas.

# RÉSUMÉ

Ce document compile les mesures d'atténuation actuellement en vigueur au sein des cinq organisations régionales thonières de gestion des pêches (ORGP thonières) qui gèrent les pêcheries ciblant les thonidés et les espèces apparentées dans le monde entier, ainsi qu'au sein d'autres organisations régionales des pêches dans l'océan Atlantique et les mers adjacentes dont les domaines de compétence incluent également la haute mer.

### RESUMEN

En este documento se compilan las medidas de mitigación actualmente activas en las cinco Organizaciones Regionales de Ordenación Pesquera de túnidos (OROP de túnidos) que gestionan las pesquerías que se dirigen a los túnidos y especies afines a nivel mundial, así como en las Organizaciones Regionales de Pesca (ORP) en el océano Atlántico y mares adyacentes, cuyas zonas de competencia incluyen también alta mar.

# 1. Tuna Regional Fishery Management Organizations (tRFMOs)

Due to the concerns on the status of sea turtles worldwide and the possible negative effects of fishing on these populations, in the last decade several Regional Fishery Bodies (RFBs) have taken conservation measures to address sea turtle interactions with marine fisheries. This document compiles the mitigation measures of the five Tuna Regional Fishery Management Organizations (tRFMOs) that manage fisheries targeting tuna and tuna-like species worldwide: the International Commission for the Conservation of Atlantic Tunas (ICCAT), the Commission for the Conservation of Southern Bluefin Tuna (CCSBT), the Inter-American Tropical Tuna Commission (IATTC), the Indian Ocean Tuna Commission (IOTC), and the Western and Central Pacific Fisheries Commission (WCPFC) (Figure 1). The currently active conservation measures across these organizations regarding sea turtles conservation are listed in Table 1.

### 2. Other Regional Fishery Bodies (RFB) in the Atlantic Ocean and adjacent Seas

According to the Fishery Governance Fact Sheets from the FAO Fisheries and Aquaculture Department (http://www.fao.org/fishery/rfb/search/en), besides those 5 tRFMOs across the oceanic areas, there are 8 other Regional Fishery Bodies (RFB) in the Atlantic Ocean whose areas of competence also include the "high seas", but whose mandates do not include fisheries for tunas and tuna-like fishes (**Figure 2**). These include the Fishery Committee for the Eastern Central Atlantic (CECAF), the General Fisheries Commission for the Mediterranean (GFCM), the International Council for the Exploration of the Sea (ICES), the North West Atlantic Fisheries Organization (NAFO), the North Atlantic Salmon Conservation Organization (NASCO), the North East Atlantic Fisheries Commission (NEAFC), the South East Atlantic Fisheries Organization (SEAFO), and the Western Central Atlantic Fishery Commission (WECAFC) (**Table 2**).

A search for sea turtle mitigation measures was also carried out on those RFBs in the Atlantic Ocean. Some of these RFBs also address turtle bycatch as part of their overall fisheries management schemes, namely the GFCM, NAFO, SEAFO and WECAFC, and those Recommendations are listed in **Table 3.** A summary of the recommendations and resolutions regarding sera turtle bycatch mitigation measures across the five t-RFMOs, as well as on other RFMOs with relevance for the ICCAT area are listed in **Table 4**.

### 3. FAO Guidelines

According to the FAO Guidelines to Reduce Sea Turtle Mortality in Fishing Operations (FAO Fisheries Department 2009), there are five major RFMOs with management responsibilities for fisheries that interact with sea turtles. Those include the ICCAT, IOTC, IATTC and WCPFC at an Oceanic level, and at a more regional level the GFCM for the Mediterranean Sea.

Still according to these FAO Guidelines, there are currently also three multilateral agreements with the primary responsibility of regional sea turtle conservation. These agreements - the *Inter-American Convention for the Protection and Conservation of Sea Turtles* (IAC), the *Memorandum of Understanding on the Conservation and Management of Marine Turtles and their Habitats of the Indian Ocean and South-East Asia* (IOSEA MoU) and the *Memorandum of Understanding Concerning Conservation Measures for Marine Turtles of the Atlantic Coast of Africa* (West Africa MOU) - address the range of sea turtle conservation and protection issues and incorporate provisions to address interactions with fisheries. Those agreements do not have fisheries management authority, but carry obligations for member states to take by-catch related actions for areas under their jurisdiction.

The FAO Fisheries Department (2009) Guidelines recognize that the Illegal, Unregulated and Unreported (IUU) Fishing may pose a threat to sea turtles because IUU vessels are unlikely to employ measures to reduce sea turtle interactions and mortality. However, several RFBs have taken steps to effectively reduce IUU fishing, including instituting requirements for Vessel Monitoring Systems (VMS), managing lists of authorized (approved) and illegal vessels, port and at-sea inspection programmes, and trade documentation programmes.




